### Statement

Brisingi Magnets / Pipio ApS declares that, based on information currently available from its supply chain and its own compliance assessment, the neodymium magnets covered by this statement comply with the applicable requirements of REACH, unless otherwise stated in a product-specific document, order confirmation, or written agreement.

### Article status under REACH

The products covered by this statement are supplied as articles. They are not supplied as substances or mixtures, and they are not intended to release substances under normal or reasonably foreseeable conditions of use.

### Candidate List substances of very high concern (SVHC) - Article 33

Brisingi Magnets / Pipio ApS monitors the Candidate List of substances of very high concern as published by the European Chemicals Agency (ECHA). Based on the information currently available to us at the issue date of this statement, Brisingi Magnets / Pipio ApS has not identified any Candidate List SVHC present above 0.1% weight by weight (w/w) in the neodymium magnets covered by this statement, unless otherwise disclosed in writing for a specific product or delivery.

If Brisingi Magnets / Pipio ApS identifies that a covered product contains a Candidate List SVHC above 0.1% w/w, Brisingi Magnets / Pipio ApS will provide the legally required information to the recipient of the article, including at least the substance name and sufficient information to allow safe use of the article.

### Annex XVII restrictions

Based on the intended use of the covered products as neodymium permanent magnets and on the information currently available to us, Brisingi Magnets / Pipio ApS has not identified any Annex XVII restriction that prevents the supply of the covered products, unless otherwise stated in writing for a specific product or delivery.
